Submission of a \$300.00 per rental week (or part there of) Reservation Deposit and return of a completed Reservation Request Form are required to hold a motorhome for the desired rental period. The reservation deposit must be submitted and this reservation request must be completed and returned on or before ____/____/200__ otherwise, the dates verbally requested will be released and the reservation deposit, if any, will be returned. Submission of the reservation deposit and return of a completed reservation request form on or before the above date are conditions precedent to any contractual obligation which Saunders RV Rentals, Inc. may otherwise have to hold your verbally requested dates.

When the \$300.00 per rental week (or part there of) reservation deposit is submitted and this completed form is returned, your reservation, subject to driver qualification, is confirmed. Once confirmed, a minimum of 30 days advance written notice is required to cancel your reservation. If written cancellation is not received 30 or more days prior to your scheduled departure date, your \$300.00 per rental week (or part there of) reservation deposit will be forfeited.

A \$500.00 per rental week (or part there of) deposit is due on the day of departure refundable within 15 business days of check in, if the unit is returned clean inside and outside and undamaged. The \$500.00 per rental week (or part there of) deposit does not apply to the rental fees. **Rental fees, estimated mileage charges, estimated LP usages (if applicable), optional cleaning fees, estimated generator usage costs, applicable taxes and all other optional fees agreed to between Saunders RV Rentals, Inc and the renter, reduced by the \$300.00 per rental week (or part there of) Reservation Deposit paid when renter's reservation was confirmed, are DUE ON THE DATE OF DEPARTURE.**

NO PETS OR ANIMALS OF ANY KIND WHATSOEVER ARE ALLOWED IN OR ON THE MOTORHOME, INCLUDING THE DRIVER'S COMPARTMENT. FAILURE TO COMPLY WILL RESULT IN FORFEITURE OF RENTER'S ENTIRE DEPOSIT. SMOKING IS NOT PERMITTED IN THE MOTORHOME AT ANY TIME !!!!!

Insurance is the responsibility of the renter and is required for the rental of a Saunders RV Rentals, Inc motor home. Renters may purchase insurance directly thru MBA Insurance Inc. by applying on line at www.MBAchoice.com (password 7274) and pay using a Visa or MasterCard **OR** renter may inquire of their Insurance Agent to determine if their personal auto insurance carrier provides coverage for the applicable Saunders RV Rentals, Inc. vehicle during the rental period (including pick up and return dates) . Saunders RV Rentals, Inc. will submit (by Fax) an INSURANCE BINDER / ENDORSEMENT REQUEST FORM to renter's Insurance Agent to aid in the process of securing the necessary documents to authenticate this option i.e.renter secures insurance through their own insurer. If the personal auto carrier is elected for coverage, **each listed driver** must submit similar information evidencing the appropriate coverage as required by state statute, completed by their own personal auto insurance carrier. Either the online insurance application or the completed and signed Insurance Binder / Endorsement must be completed no later than 2 weeks prior to departure.

Saunders RV Rentals, Inc. requires and will request a motor vehicle report (MVR) for all drivers listed above. Saunders RV Rentals, Inc. reserves the right to cancel a reservation and return the reservation deposit based on the information disclosed on the motor vehicle report. Saunders RV Rentals, Inc. shall not be liable for damages caused by such cancellation.

By placing your driver's license information on this Reservation Request Form or by allowing a third person to do so, all drivers listed above authorize Saunders RV Rentals, Inc. and it's agents, to obtain their drivers' record and disclose same to third persons, including but not limited to, Saunders RV Rentals, Inc. motor-home insurer, other drivers listed above, and authorized employees and agents of Saunders RV Rentals, Inc. Additionally, all drivers listed above agree to hold Saunders RV Rentals, Inc. harmless for any and all potential liability for disclosure of any listed driver's motor vehicle record.

In it's sole discretion, Saunders RV Rentals, Inc. reserves the right to postpone a departure to correct or repair a condition, which makes the motorhome you reserve unsafe or inoperable. In the event Saunders RV Rentals Inc. exercises this right, renter agrees to hold Saunders RV Rentals, Inc. harmless for any and all damages caused by such postponement or revised departure date(s).
